#### NOTIFICATION

The following Act passed by the Sikkim Legislative Assembly and having received assent of the Governor on 04th day of April, 2022 is hereby published for general information: -

## THE CAPITAL UNIVERSITY ACT, 2022

(ACT NO. 10 OF 2022)

ACT

to provide for the establishment and incorporation of the Capital University in the State of Sikkim, and to confer the status of a Private University thereon and for matters connected therewith and incidental thereto:

Whereas, with a view to provide major boost in terms of academic upliftment in all phares of knowledge it is essential to impart education in almost all areas including Management, Engineering, Law, Communication, Insurance, Behavioural Science, Fine Arts, etc. to the youth at their door steps.

And whereas Ch. Charan Singh Educational Society is registered under Societies Registration Act, XXI of 1860 having registration no. S-55338 of 2006 dated 07th April 2006 and the Charan Singh Educational Foundation has been incorporated under the Companies Act, having corporation no. U80210DL2021MPL387152 of 2013 on 26th September 2021 under Ministry of Corporate Affairs, Government of India.

And whereas Ch. Charan Singh Educational Foundation (CCSEF) intends to establish Capital University with the objective to provide Higher Education with skilled and entrepreneur courses in Sikkim through world class infrastructure and international networking which will catalyse not only the surrounding region but the State as a whole.

**BE** it enacted by the Legislative of Sikkim in the Seventy-third Year of the Republic of India, as follows:

#### CHAPTER I

#### PRELIMINARY

- Short title, extent 1. (1) This Act may be called the Capital University Act, 2022.
- commencement.
- It shall extend to the whole of Sikkim.
- It shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.

#### Definitions.

- 2. In this Act, unless the context otherwise requires:
  - "Academic Council" means the Academic Council of the University as specified in Section 24 of the Act;
  - "Annual Report" means the Annual report of the University as referred to in Section 39 of the Act;
  - "Board of Management" means the Board of Management of the University as constituted under Section 23 of the Act;
  - "Campus" means the area of the University in which it is established;
  - "Chancellor" means the Chancellor of the University appointed under Section 12 of the Act;
  - "The Chief Finance and Accounts Officer" means the Chief Finance and Accounts Officer of the University appointed under Section 18 of the Act;
  - "Controller of Examinations" means the Controller of Examinations of the University appointed under Section 19 of the Act;
  - (h) "Constituent College" means a college or an institution maintained by the University;
  - "Employee" means employee appointed by the University; and includes teachers and others staff of the University or of a constituent college;
  - "Endowment fund" means the endowment fund of the University established under Section 37 of the Act;
  - "Faculty" means group of academic departments of similar disciplines;
  - "Fee" means collection made by the University from the students for the purpose of any course of study and incidental thereto, in the University;
  - (m) "General Fund" means the General fund of the University established under Section 38 of the Act;
  - "Governing Body" means the Governing Body of the University constituted under Section 22 of the Act;
